




**Child mortality (age 1-5)** 





Child poverty strategy for Wales: strategy and progress | GOV.WALES



Objective 1: to reduce costs and maximise the incomes of families.



Objective 2: to create pathways out of poverty so that children and young people and their families have opportunities to realise their potential.



Objective 3: to support child and family wellbeing and make sure that work across the Welsh Government delivers for children living in poverty, including those with protected characteristics, so that they can enjoy their rights and have better outcomes.



Objective 4: to ensure children, young people and their families are treated with dignity and respect by the people and services who interact with and support them and to challenge the stigma of poverty.



Objective 5: to ensure that effective cross-government working at the national level enables strong collaboration at the regional and local level.



## Percentage of children living in relative income poverty (after housing costs)





Over half of households with children have **gone** without heating over the previous three months





One in five (21%)
households with
children have reduced
the size of their
child's meal or
skipped a meal of
their child

Nearly half (45%) of 7-11 year olds in Wales, and a quarter (26%) aged 12-18, are worried about having enough food to eat



Children living in cold homes are seven times more likely to have four or more negative mental health symptoms



Children in the lowest household income quintile are seven times more likely to experience 1+ ACE than the most affluent children

## Living in the most disadvantaged areas in Wales means you are...



nearly 2 x as likely to be obese at age 4-5



nearly 5 x as likely to be repeatedly absent from school



nearly 5 x as likely to have no qualifications as an adult



nearly 5 x as likely to live in overcrowded housing



and 2 x as likely to have a chronic condition

...compared to those in the least


